Please note:

- The excitement of training can cause some beginner dogs to momentarily lose focus and snap at another dog. For this reason, it is essential that only the dog that is working on a particular exercise, be off the leash. All other dogs must be leashed and under the control of the Handler at all times.
- Agility is a labour intensive sport. There may be setup required at the start of your class (i.e. raising or lowering the Aframe, attaching or removing the ramps from the Dogwalk, minor movement of obstacles for sequencing, etc.). Setup will be performed during the allotted lesson time. Students are required to assist, where requested, with the lifting/moving or assembly of equipment as identified by the instructor.
- Applications cannot be accepted without a signed Insurance Waiver.

Insurance Waiver

In consideration of the acceptance of this registration by Dream Fields Training Inc. and the opportunity to have the Dog participate in a class, I, the undersigned, agree as follows: 1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs. 2. I agree that Dream Fields Training Inc., may refuse my entry for any reason that it deems to be sufficient. 3. I understand and acknowledge that participation in the Class carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my "Related Parties"), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue Dream Fields Training Inc., or any of the directors, executives, committees, representatives, employees, volunteers or agents of Dream Fields Training Inc. (the "Personnel"), for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind. 4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event.
